With the cooperation and leadership of State, this planning process proved extremely useful in people's participation and monitoring of programmes. I seek your leadership and coordination to make the exercise useful.

2. Besides preparation of the Gram Panchayat Development Plan (GPDP), we also did an assessment and ranking of every Gram Panchayat to understand the deficits on development. We propose to do the same exercise again to see whether there has been any improvement in the ranking of Panchayats over the last one year. We are also trying to capture the dynamic change on household indicators in selected Gram Panchayats based on the Socio Economic Census (SECC) baseline.

I would like to request you to convene a meeting with the Additional Chief Secretary, the Principal Secretary (Panchayati Raj & Rural Development) to facilitate effective implementation of the programme. The detailed guidelines have been sent by the Ministry of Panchayati Raj. The Department of Rural Development will also send all details regarding ranking of panchayats etc at the earliest.

This Campaign was implemented quite effectively *inter-alia* in partnership with the State and Local Governments by capacitating the Gram Panchayats (GPs) Gram Sabhas for making the entire process of GPDP formulation participatory and convergent.

I also wish to congratulate all the State Governments, particularly the Panchayati Raj and Rural Development Departments of the State Governments for successfully completing all the activities of the Campaign right from appointment of Nodal Officers and facilitators at appropriate levels to uploading of final GPDPs in PlanPlus and submission of report by facilitator.


3. Inspired by the visible and quite satisfactory performance of the Gram Panchayats, Gram Sabhas and other stakeholders involved in the PPC last year and to provide sustainability to the GPDP formulation process into a participative and transparent exercise, it has been decided to launch the process of preparing GPDP for the financial year 2020-21 again from 2<sup>nd</sup> October, 2019 in a Campaign mode on the pattern of last year's Campaign. The role out of the preparatory work for GPDP has to be strictly as per the stipulated timeline and the details of same are as follows:-
