Dear Colleague,

As you are aware, the Mission Antyodaya Survey, 2022-23 has been launched by Hon'ble Minister of Rural Development and Panchayati Raj on 10th Feb., 2023. The survey aims to lend support to the process of participatory planning for Gram Panchayat Development Plan (GPDP) which will improve service delivery, create pace for an alliance of people's institutions, and groups and improve governance at the local level.

2. Under this Survey, around 92000 Cluster Resource Persons (CRPs) are collecting village level data through a questionnaire hosted on a web based mobile application developed by the NIC. The survey involves facility survey and reporting of information available at the local level.

3. In order to ensure the accuracy of the data reported under the survey, it has to be validated at Gram Panchayat level by organizing a Gram Sabha. Each Gram Panchayat is required, in terms of Gram Panchayat Development Programme (GPDP) guidelines, to conduct two Gram Sabhas to finalise and approve its development programme. It is advised that each Gram Panchayat should convene the 1st Gram Sabha during February 25 March 10, 2023 to authenticate the MA survey data of villages collected by the CRPs. In case, some Gram Panchayats have already convened their first Gram Sabha, the second Gram Sabha may be convened to authenticate the Mission Antyodaya Survey, 2022-23 apart from transacting other agenda.

4. The protocol for the authentication of the survey data is enclosed. As per the protocol, a geotagged video recording of the proceedings of the Gram Sabha will have to be uploaded through the Mission Antyodaya mobile application. The data collection under the survey for a Gram Panchayat will not be considered closed till the uploading of the geo-tagged video of the Gram Sabha meeting called for authentication of the data. The video recording, stored in Vibrant Gram Swaraj portal, will also have to be approved by the Block Development Officer for its final acceptance.

5. We would therefore, also request you to sensitise the district-level and the block-level functionaries, apart from the State level nodal authorities, regarding their role in regular monitoring of the survey activities and convening of the Gram Sabha.

Step1: Community Resource Person to read out in the local language the complete data of Gram Panchayat against 216 questions in the questionnaire.

Step2: Recording of Video in the Mission Antyodaya mobile application while reading out the text below:

Respected Sarpanch ji and all the Gram Sabha members, it is informed today (*date to be read out*) to all of you that the Mission Antyodaya Survey, 2022-23 has been conducted for the Villages _____, _____, (names of all villages) falling under the jurisdiction of this Gram Panchayat _____ from _____ to _____. The Community Resource Person has read out to you the data collected against 216 questions from the villages in your Gram Panchayat.

As noted by you, this survey data mainly includes the information on the availability of various services and facilities such as hospital/ health centre, school, Common Service Centre, Seed Centre, Veterinary Clinic, Bank, sanitation facilities, beneficiaries and coverage under various government schemes, number of Kaccha houses etc. in our Gram Panchayat.

Whether all the Gram Sabha members present in the meeting agree with the information presented by the Community Resource Person in the Mission Antyodaya Survey, 2022-23 data?
