Dear Madam/Sir,

As you may be aware, the Department of Rural Development has been conducting Mission Antyodaya (MA) Survey across all Gram Panchayats in the country since 2017-18 with the purpose of transforming lives and livelihoods of people on measurable outcomes through convergence of various schemes. The MA Survey data are deployed for preparing GP-wise gap reports and their rankings. While the rankings provide some understanding of relative success of convergent planning at GP level, the gap report serve as critical inputs for preparation of Gram Panchayat Development Plan (GPDP) not only for current year but also for years to come and guide decisions on funding of 15th FFC.

2. In the last survey, data on 143 parameters of 29 subjects, transferred to local self-Governments under 11 Schedule of Constitution, were collected. Now, the MA Survey, 2022 is being launched countrywide from 10th January, 2023 to collect village level data on 216 data points covering 182 parameters of 21 sectors. The Survey questions have been categorized into 5 strata of (i) Panchayat Infrastructure (ii) Panchayat Services (iii) Village Infrastructure (iv) Village Services and (v) Village Practices.

3. The proposed MA Survey, 2022 will be conducted by mobilizing services of 92,000 Cluster Resource Persons (CRPs). Each village will be surveyed by one CRP in 3 days through a web-based mobile application developed by NIC. The CRPs will be paid honorarium of Rs.400 per-day plus Rs.200 TA/DA for conducting survey from out of the funds provided to State under Administrative Head of Mahatma Gandhi NERGS. The training for the survey will be rolled out in cascading mode w.e.f. 22nd December, 2023. **The detailed timelines for training and conduct of Survey is enclosed.**

4. I hope that the State will extend its full cooperation in conducting the MA Survey 2022 as per the given time line so that the outcome of survey can be utilized for preparation of GPDP by the States.
